I further understand that dogs, irrespective of their training and usual past behavior or characteristics, may act or react unpredictably at times based upon instinct or circumstances, and I agree to assume the risk of injury to me, any individual accompanying me during the Event, and my dog(s). I understand that the risk may result from fierce, aggressive, vicious and dangerous dogs, which may be present at the Event.

I further warrant that my dog(s) are current on his/her vaccinations and are spayed/neutered.

I further understand and assume the risk that:

- Not all dogs present at the event May have received the rabies vaccine as required by law,
- Not all dogs present at the Event may have been vaccinated for distemper or parvo, all of which could result in injuries to humans and other dogs;
- Dogs may escape over or under fences or through gates or otherwise.
- Plants, water and/or other sources at the event may be poisonous to dogs,
- Vegetation or other matter may have burrs or seeds that could become tangled in a dog's coat or lodge in a dog's fees, ears, nose, or eyes,
- Mosquitos, fleas, or other insects and animals may be present at the Event.

Any or all of these may injure or infect my dog(s). I understand and expressly assume all additional risks.

It is my understanding that no agent or employee of Springhurst Homeowners Association will supervise or be responsible for any dogs at the Event at any time. I understand that I am responsible for my own dog(s) at all times during the Event. I further understand that the Springhurst Homeowners Association does not assume liability for loss, damage, for any kind of injury sustained by any human or dog while at the Event. I, therefore, expressly assume all risks associated with attending the Event, as well as fixtures and equipment located therein, in an unsupervised manner.

By signing this release of liability and attending the Event, I hereby fully and forever release and discharge the Springhurst Homeowners Association, their employees and agents from any and all claims, demands, damages, rights of action, or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my attendance at the Event. I fully and forever release and discharge Springhurst Homeowners Association, and their employees and agents from any and all negligent acts and omissions in the same, and intend to be legally bound by this lease.

I have carefully read this release of liability and understand and fully agree with its contents. I also have received a copy of the Rules for Attendance, etiquette for dog owners and recommendation for dog owners. This is a release of liability. - 1. The Event takes place on September 4th from 6:00 pm until 7:30 pm.
- 2. No dogs are allowed without a signed APPLICATION and WAIVER AND RELEASE OF LIABILITY by its owner:
- 3. No vicious dogs are allowed. All fights between dogs must be attended to by the dog's owners;
- 4. Owners are legally responsible for their dogs and any injuries or damages they cause whether to person or property;
- 5. Owners must be inside the fenced area of the pool at all times while their dogs are in the pool area; Dogs are not to be left in the pool area unattended;
- 6. Leash laws apply outside the fenced pool area; Children under 14 are not allowed in the fenced area unless accompanied by a responsible, legal adult;
- 7. Dogs must be spayed or neutered to attend the Event and owner must warrant current vaccination status of his/her dog;
- 8. Gates must remain closed except when entering or exiting the off-leash pool area.
- 9. Dogs must wear collars with their proof of vaccination provided by St. Charles County;
- 10. Limit 2 dogs per household within Springhurst Homeowners Association;
- 11. Maximum of 25 dogs in pool at a time;
- 12. KEEP POOL AND SURROUNDING AREAS CLEAN! Pick up after your dog. Place all dog waste and trash in designated receptacles.
- 13. NOT ALLOWED AT THE EVENT:
 - Dogs that have not been spayed or neutered
 - Vicious dogs
 - Animals other than dogs
 - Puppies under 4 months old
 - Dogs that are injured or in poor health
 - Glass of any kind
 - Food of any kind, for humans or for dogs
 - Smoking
